"I was a California Department of Public Health employee between 2009 to 2023.

"On April 14, 2022, Department of Health and Human Services Secretary Xavier Becerra said this about COVID-19 vaccines:

""We know that vaccines are killing people of color, Blacks, Latinos, Indigenous People at about two times the rate of White Americans."

"On April 18, 2022, I informed Deputy Director what Becerra said.

"I emailed Vaccine Adverse Events Reporting System data about COVID-19 vaccine allergic reactions, facial paralysis, miscarriages, heart attacks, heart inflammations, seizures, strokes and sudden deaths.

"I informed Deputy Director there were 26,976 COVID-19 vaccine deaths.

"**On October 13, 2022**, I informed Deputy Director there were 31,330 deaths. I noted that in 2003, the small pox vaccine program for healthcare workers was halted just after two deaths!

"I noted that VAERS data reflects only a small number of actual injuries and deaths.

"I was <u>told</u> my COVID-19 vaccine concerns conflicts with the Department. I was <u>threatened</u> with disciplinary action. I was <u>issued</u> a counseling memorandum.

"On September 6, 2023, CDPH Assistant Director emailed me and wrote 'Secretary Becerra misspoke, and was actually discussing deaths associated with COVID-19, not the vaccines.'

"Between 1992 to 2023, I held Public Information Officer positions at the Governor's Office of Emergency Services, the Department of Motor Vehicles, the California Community Colleges Chancellor's Office, and the California Department of Public Health.

"During my nearly 30 years with the state, I handled many news releases. Anytime there's a misstatement, we corrected and resent the news release.

"Becerra's quote is still on the White House's official YouTube channel.

"Californians were told COVID-19 vaccines 'are safe and effective.'

<u>That is a lie</u>!

"I prematurely retired so state public health officials could not muzzle truth from the public.

"Last year I emailed a five-page PDF detailing all this to <u>296</u> county-elected, and <u>62</u> administratively appointed local California officials.

"I urged —and am still urging — Board of Supervisors to direct County Health Officers to stop promoting, administering and distributing COVID-19 vaccines, in accordance with California Health & Safety Code 101025, which states, '*The Board of Supervisors of each county shall take measures as may be necessary to preserve and protect the public health.*'

"I would not have <u>emailed</u> 'COVID-19 Vaccine Warning' to California's 58 Board of Supervisors last July and last December, <u>rode</u> on my motorcycle more than 7,000 miles, <u>spoke</u> at 35 county Board of Supervisor meetings the past year, and <u>alerted</u>, the California Board of Pharmacy —if I was not convinced that COVID-19 'vaccines are killing people.'

"Having heard my comment—if any FDA Advisory Committee member <u>still</u> endorses COVID-19 vaccines, history will record that they, along with California state and local officials, were complicit in allegedly committing crimes against humanity!"

(This was **Ronald F. Owens Jr.'s** Food and Drug Administration's (FDA) May 22, 2025, Vaccines and Related Biological Products Advisory Committee four-minute public comment.)

The FDA's Vaccines and Related Biological Products Advisory Committee members heard from six COVID-19 vaccine opponents on May 22, 2025.

I was one of those six speakers invited to speak at the hearing. The six of us and our other ideological opponents were selected via lottery from the more than six thousand written commenters.
