**Topic: COVID-19 Vaccines Administered at Oceanside
August 19, 2026**

CDPH MUZZLED TRUTH ABOUT COVID-19 VACCINE RISKS

- On April 14, 2022, Health and Human Services Secretary Xavier Becerra said this about COVID-19 vaccines: “*We know that vaccines are killing people of color, Blacks, Latinos, Indigenous People at about two times the rate of White Americans.*” (45:50 mark of 4/14/22 White House Convening on Equity” summit.
- On April 18, 2022, **informed** management about Secretary Becerra quote, **shared** information from VAERS that Californians have suffered allergic reactions, facial paralysis, miscarriages, heart attacks, heart inflammations, seizures, strokes, and sudden deaths from COVID-19 vaccines, **recommended** CDPH leadership, California Health & Human Services Secretary and Gov. Gavin Newsom be made aware.
- On October 13, 2022, revisited the alarming issue with CDPH management.

- From August and September 2023 until the time I retired on December 31, 2023, I informed CDPH about this public health emergency.

WHAT HAS NOT BEEN REPORTED

- White House officials, CDC officials, American Academy of Pediatricians, Dr. Anthony Fauci and CDC Director Dr. Rochelle Walensky knew in May 2021 COVID-19 vaccines were injuring and killing.
- Dr. Anthony Fauci received news on June 19, 2021 that he had blood clots in his lungs after taking the COVID-19 Moderna shot, but he didn't divulge that to anyone, according to his own writings widely reported as the Fauci Diaries.
- Dr. Anthony Fauci knew that COVID-19 vaccines have been injurious to pregnant women.
- As of July 31, 2026, there were **97, 505 COVID-19 vaccine injury California cases**, and from that number, sadly **764 Californians died from COVID-19 vaccines**, according to [MedAlerts.org](https://www.medalerts.org).
- These figures represents less than one percent. Add a couple zeroes to get actual vaccine injury California cases and deaths.
- **9, 750,500** vaccine injured and **76,400** deaths in California!

FEDERAL GOVERNMENT FAILURES

- H&HS Secretary Xavier Becerra didn't notify you.
- Submitted written statement to FDA's Vaccines and Related Biological Products Advisory Committee, and provided public comment on May 22, 2025.
- Submitted written statement to CDC's Advisory Committee on Immunization Practices, and provided public comment on June 26, 2025.
- Food and Drug Administration and Centers for Disease Control and Prevention hasn't been reactive.

CALIFORNIA STATE GOVERNMENT FAILURES

- Did California Department of Public Health notify you. Nope. CDPH's position is COVID-19 "vaccines are safe and effective."
- Did California Board of Pharmacy (BoP) notify the 20 or more Oceanside pharmacists? I suspect not. BoP's position is COVID-19 "vaccines are safe and effective."

- On August 18, 2026, appeared in-person
- On August 18, 2026, provided written comment
- Did BOS notify Oceanside?

MAINSTREAM MEDIA FAILURES

- Since December 2024 urged California News Publishers Association; California Broadcasters Association; Chico

Enterprise-Record; Action News Now, Chico; KCRA-TV (NBC/Sacramento); KQVR-13 (CBS/Sacramento); The Washington Post; The New York Times; Bloomberg; POLITICO, etc., etc., etc. to report about this public health emergency.

OCEANSIDE

- There are a reported 483 municipalities in California's 58 counties.
- Oceanside is one of 18 cities in San Diego County
- Dr. Sandra Martinez, an Oceanside resident, asked me to address the Oceanside City Council.
- Oceanside has approximately 20 pharmacies.
- Even though I urged San Diego County Board of Supervisors to stop promoting, administering and distribution COVID-19 vaccines, COVID-19 vaccines are still being administered at Oceanside pharmacies and elsewhere throughout the County.
- Your residents need to be informed that COVID-19 *"vaccines are killing people..."*
